

Post-Graduation Work Permit (PGWP): Online Eligibility Questions

When you begin your application for a **Post-Graduation Work Permit (PGWP)**, you will need to: Log into or create an *online IRCC account*.

- 1. Respond to a series of "Eligibility Questions" so that the system can identify what type of application you need to
- 2. submit. Below is a guide to some of the appropriate answers for the eligibility questions. Please note that this is not a complete list and you should answer all questions accurately according to your particular circumstances, if they differ from the recommendation below.
