## **GUEST PRESENTER**

## **Brett Sharman, Professor & Program Coordinator**

Brett Sharman provided the board with a presentation on the Sustainable Development Goals (SDG) and an update on the work the college has done. The focus of the presentation was on the SDG Accord and how SUCCI can get more involved by signing the accord. The suggestion is to have SUCCI sign the accord during SDG week. As a student union, if SUCCI decided to sign, they would not have any reporting requirements in the same way Confederation College does. Signing it would be a public gesture and to be more intentional in any sustainability related efforts. The Student Union at Georgian College has signed the accord, Ronnie will reach out to his counterpart there to get more information. The board agreed to look at the information further and discuss how SUCCI can best participate.

## **ITEMS FOR DISCUSSION**

#### **Elections 2023**

Elections campaigns are now underway. There are two candidates for President, two candidates for Vice-President, and two candidates for Senator of Health, Negahneewin and Community Services. Senator of Technology has been acclaimed. Board members are encouraged to remind students of the voting period on Feb 21-23, a unique email link will be sent to each individual student that is eligible to vote during that period. All board members are invited to attend the event on the 24th to meet the new SUCCI board members.

## **SUCCI Policy Review**

As mentioned previously SUCCI policies are being reviewed for inclusive and gender-neutral language, board members are asked to review policies beyond their job description to look for items that need to be updated and/or changed. OASA has also expressed that they are looking to make their policies more inclusive. SUCCI and OASA will work together to ensure all policies are inclusive.

#### **Ontario Student Voices**

SUCCI still needs to name an OSV representative as a replacement, board members are asked to express their interest as soon as possible as there is an upcoming meeting. Clarification was provided around the commitment of a representative. Meetings are held virtually once a month, typically for 2 hours and eee scheduled around participants' availability.

# **Accountability Policy**

An email has been sent by the president containing notes and the research around accountability policies. Board members are asked to review this and bring questions to Ronnie prior to discussing further and making decisions.

## ITEMS FOR DECISION

## Compensation

"Be it resolved that a motion be put forward that the president's salary be increased by 3% annually, and that the honorariums have a one-time increase of 3%."

A thorough discussion was had around the board's compensation for the 2023-2024 academic year, based on the recommendation of the compensation committee of a 3% increase. This recommendation was based on the previous compensation report information.

Additionally, the microwave in the McIntyre is broken and needs replacing. SUCCI staff will look into any potential safety concerns and why the kettle was removed, as well as replace the microwave for McIntyre.
