# Welcome

Vignesh welcomed everyone to the meeting, and also our two new Board members. Kaitlyn O'Gay, Senator of Aviation and Julian Estrella, Director of Health, Negahneewin and Community Services. Furthermore, an official welcome to Gailynne, OASA representative, as she could not attend the last meeting. Everyone introduced their roles and positions on the board.

# Adoption of the Agenda

#### Items for Discussion

#### Foosball Table (McIntyre)

Robin noted there have been many complaints by the students at the McIntyre building, with regards to the condition of their foosball table. Robin had done some research on pricing and is looking for approval to purchase a table for McIntyre. The info has been provided to the Executive committee to review and see if funding for the item is available, as it was not included in the 2022-23 budget. Kaitlyn also addressed a concern, that the Aviation Centre did not have any form of gaming entertainment either and would it be possible for that building to have a foosball table or some form of game as well. The executive committee will review next week and bring to the board for cost approvals.

#### **Retreat feedback**

Overall, everyone enjoyed the retreat weekend. They all noted Jim Lees was a great facilitator and also enjoyed getting to know everyone on a more personal level. They also enjoyed the structured activities presented by Thomas. Kiran had mentioned that the last retreat he attended, there were more games, dancing and entertainment in the evening. The SUCCI administrative staff will also review the weekend activities and brainstorm for ideas and suggestions for future retreats.

#### **Ancillary Fees**

Kendall presented the agreement between Confederation College and SUCCI with regards to how the procedures work for student ancillary fees. Any increase to a student fees must be reviewed and approved by the SUCCI board, before it can proceed to the college's board of governors. Fees for fall of the following year, are usually approved quite early in the semester (October), so that there is ample time to get posted for the New Year. Don Duclos, will attend our October 19<sup>th</sup> meeting to discuss these fees. In the coming weeks, the Executive Committee will review and make suggestions on these fees, and final approval to come before the board.

#### Splashtop/Laptop

Robin and Hyunjoon discussed a concern for some student's still needing access to use Splashtop to access important programs related to the studies of their class. (Splashtop is a program that allows any student user, access to college computers remotely) Students were given access during the Pandemic to Splashtop (due to classroom restrictions), but now the college has chosen not to renew more licenses. Many students are concerned, as they cannot access the same program capabilities, they were accustomed to using. As suggested by others, Ronnie and Kendall will bring this issue up to IT, VPA or Academic Council and see if there can be an exception made for limited licenses for this year, so that students who had previous access can continue using this software. Robin also addressed a concern for students not able to come on campus due to illness or COVID restrictions. Alyssa noted that if any student is ill or unable to complete assignments due to illness, that they should contact their program coordinator and student success to discuss an option for an accommodations plan.

Gailynne updated everyone on the upcoming elections for OASA. Some candidates have put up posters amongst the college and a debate for candidates is set to happen next week in the SUCCI lounge. Gailynne also let us know that voting is open to all students. Kaitlyn also mentioned she could put up posters in the Aviation building. In other news, she is hoping to create a Retreat style event for their OASA board members as well. Kendall noted to reach out to Darcy McWhirter to discuss the budget piece as funds are set aside for their board.

Julian brought up a need for some students interested in creating a dance group and having access to the Wellness Centre spaces. There is a room available in the Wellness Centre that can be booked. Alyssa will look into whom you can contact to book that space. Another suggestion is that if there is a need for many people wanting to create a dance club that they can always apply to be certified as a SUCCI sanctioned Club. They can speak with Ashley or Thomas in SUCCI for more info.
