DSW Learning Platform – Program Specific Mandatory Fee

This a new fee that will be charged only to DSW Students. Students have really benefitted by using the platform which has been piloted with the current students in the program. The platform helps to bridge the gap between theory and practise and also serves to augment and diversify the learning experience. The platform will provide more depth and breadth in their learning. The board suggested that it would be beneficial for students to be able to keep the platform when they leave the program similar to what they can do with textbooks. Don will follow up. Currently they only have access to the platform when they are a student.

Ombuds Service & Ombuds Fee

The Ombuds Advisory Committee met. President Kathleen Lynch proposed not filling the position of Ombudsperson and asked that the Ombuds Advisory Committee consider a new model which may better serve students. The part time position of Equity & Human Rights Advisor will be combined with a student appeals advisor portion to replace the Ombuds Position. Based on the annual reports a lot of the concerns the Ombudsperson received should be handled through Student Success as well as the Academic Advisors. Counsellors are there to help students with anything that is negatively impacting them and affecting them and is a discreet confidential service. The fee for the Ombuds Service will not be charged for the Winter Semester and possibly Fall 2022 as SUCCI should have enough student funds in the Ombuds Service budget area.

An updated position is currently posted. The title is Diversity, Equity, Inclusion & Student Appeals Advisor. Board members expressed concerned with the title and felt that students will not understand. The title it is too formal for the student body. It is suggested the title be changed to something shorter such as Student Rights Advisor. Marketing of the service will be important so students know the service exists. There will be some sharing of costs similar to the Ombuds Service and there will be a committee similar to the Ombuds Advisory Committee. The committee can review how the new service is working for students once it has been put in place and operational.

Library – First Floor & Building Hours

David Johnson has received complaints that there is nowhere to print in the evening in the Shuniah Building. There is also confusion with the building hours of operation and students being asked to leave the library. The hours are not consistent with the building hours and there is confusion and disconnect. Ronnie will follow up. Students do like to use the library to study and currently on the weekends they are being asked to leave at the end of the day. If the building is open like Food Services, students should be able to continue to study in library area. There are inconsistencies with hours on google. Don Duclos will follow up.

Approval of Student Records Fee
